Josiah D. Albritton

Pactolus, Pitt County, North Carolina,

Son of James B., Grandson of Samuel, Great-grandson of James, Great-great-grandson of Peter, & Great-great-great-grandson of James Albritton Sr.

Josiah D. Albritton was born on 15 October 1836, presumably on the old plantation of his grandfather near Pactolus, Pitt County, North Carolina. Josiah's uncle, Elder Benjamin B. Albritton, identified him as the son of James B. Albritton and recorded Josiah's birthdate in his family Bible [1]. Additionally, Josiah's maternal grandmother, Elizabeth Moore, identified him as her grandson and as the son of Penelope Moore Albritton in her 1850 will [2].

James B. Albritton died in April 1840 when Josiah was only three years old, and so the boy likely had no memory of his father [3]. He and his older brother, Edmond, were raised by their mother, Penny, and maternal grandmother, Elizabeth Moore, on the old plantation of their grandfather, Matthias Moore Jr., with their uncles, Wedigan and Edmond Moore, living on adjoining farms [4]. Wedigan Moore died at the age of forty-eight on 5 November 1857, and two months later, on 6 January 1858, Josiah's other uncle, Edmond Moore, conducted a sale of Wedigan's property at his farm. Josiah D. Albritton purchased the following items at the indicated prices [5]:

Josiah D. Albritton married about 1859 or 1860, probably in Pitt County, North Carolina, to Penelope Ann Harrington [Penny] (June 1840–9 June 1914), daughter of Isaac Harrington and Elizabeth Tucker [6]. Penny's uncle, Henry Harrington, had married Josiah's aunt, Tabitha B. Albritton about 1830, and so Josiah and Penny had grown up on nearby farms with their families interconnected prior to their births [7].

In 1860, Josiah and his new wife lived with her widowed mother and grandmother in the Pactolus community on the north side of the Tar River. Between the three of them, they owned a large plantation, with Josiah's real estate valued at \$500, his mother-in-law's real estate at \$2000, and his grandmother-in-law's land at \$500. All three also had valuable personal estates, mostly consisting of slaves, with Josiah's valued at \$4000, Eliza Tucker Harrington's at \$5000, and Penny Tucker's at \$3000 [8]. Josiah owned two slaves, while Eliza owned three and her mother, two [9].

On 14 April 1862, Josiah D. Albritton enlisted as 4th Corporal in Company K, 17th North Carolina Infantry Regiment at Camp Mangum. In his first month in the training camp, he became ill and on May 30th, he was *"Sick at home"* [10]. Apparently after returning to his unit, on June 20th, *"owing to the unsetting* [sic] *of my earthly existance,"* Josiah wrote his will, leaving all of his property to Penny. He appointed *"my frind"* Samuel H. Langley as his executor, directing him to

...prepare for my body a desent buriel sutible to the wishes of my friends and shall pay all funeral expenses first out of the estate which may go into his hands... [11]

Josiah D. Albritton recovered and returned to service. His commanding officers listing him as present for duty on June 30th. However, he again became sick while stationed at Camp Campbell, Virginia. The army physicians diagnosed him with typhoid fever, and he succumbed to the malady on August 8th [12].

If Josiah and Penny had any children, they did not survive infancy. Penny remarried on 6 February 1866 in Pitt County to Samuel Adolphus Dudley [Dolphus] (1 Nov 1836–24 May 1910) [13]. Dudley had served in the Confederate Army, enlisting in August 1861. Captured in the Battle of Cold Harbor on 31 May 1864, he spent the next ten months as a prisoner of war at Point Lookout, Maryland and Elmira, New York. The Union officials paroled him on 14 March 1865 and took him to James River, Virginia for his official exchange [14]. Penny and Dolphus farmed and raised their family in the Pactolus neighborhood for the rest of their lives [15]. Dolphus Dudley died on their farm about five miles north of Greenville on 24 May 1910, and Penny died there five years later, on 9 June 1914, of *"senile debility"* [16].

Incidentally, at least one published work on the Albritton family misidentifies Penny, wife of Samuel Adolphus Dudley. That work claims her maiden name was *"Albritton,"* but the documentation given herein clearly shows those claims are bogus. Dolphus Dudley indeed married the woman born as *"Penelope Harrington,"* the widow of Josiah D. Albritton [17].

It is unclear if this were a transcription error, an error Benjamin made while recording the death of his nephew, whose military record clearly states that he *"Died Augst 8th 1862 at Camp Campbell, Va.,"* or if this Albritton male is an older and otherwise unidentified man with this name who indeed died on 13 October 1831. Incidentally, that date was merely six weeks following Samuel Albritton's death.

...passed away Tuesday...about 11 o'clock a.m. at his home 5 miles from town. Mr. Dudley was 74 years old, and while he had been feeble for a year past, he was up Tuesday morning until a short while before his death.

Albritton states that Penelope Albritton who married Adolphus Dudley on 6 February 1866 was the daughter of Matthew Albritton (14 Jan 1813–20 Aug 1893), son of John Hodges Albritton. He apparently failed to realize that the 1866 marriage of Penny Albritton to Dudley was her second marriage, and so the marriage record used her married name. The identities of Penny's parents and her own maiden name are clearly documented in Penny's death certificate and that of her son. Hers lists her parents as *"Isaac Harrington"* and *"Pennie Tucker,"* whereas Samuel Isaac Dudley's certificate lists his parents as *"Samuel A. Dudley"* and *"Penny Ann Harrington."* Incidentally, Penny's own death certificate incorrect listed her mother's given name, which was actually *"Elizabeth Tucker Harrington,"* whose own mother's married name was *"Penelope Tucker."*
